It is also understood that Andrew DeZutti Photography may take additional photographs that may be used for advertising, display or any purpose thought proper by Andrew DeZutti Photography.
2. Images/files will become the property of the Client upon receipt of a separate payment in an amount agreed upon by Andrew DeZutti Photography and the client.
3. Although all care will be taken with the images/files taken at the wedding, we limit the liability for loss, damage or failure to deliver the pictures for any reason to the return of all deposits made. We limit all liability for the images/files once they are turned over to the client. This includes but is not limited to inferior lab processing.
4. It is understood that no other Professional photographer shall be allowed to photograph at the wedding while Andrew DeZutti Photography is working, and that breach of this agreement will constitute a reason for non-completion of the job with no liability to Andrew DeZutti Photography and loss of the entire package cost by the client including deposits.
5. Upon signature Andrew DeZutti Photography reserves the time and date agreed upon, and will not make other reservations for that time and date. For that reason, all deposits are non-refundable, even if date is changed or wedding is canceled for any reason.
6. A deposit of 50% of the package price is due at the signing of this contract. The additional one half of the total package price is due 5 days before the wedding date. Any cancellations within 48 hours of the event date will result in forfeiture of the entire package cost by the client including deposits.
7. Andrew DeZutti Photography agrees to provide the services and products required for the package listed above in a timely fashion
